# On October 11, 2012, we will celebrate the fiftieth anniversary of the beginning of Vatican II, an ecumenical council whose impact is still being felt.

In calling this council, Blessed John XXIII had two major goals: he desired Christian unity, taking steps to have official observers from the Orthodox and Protestant Churches present at the council and to establish the Secretariat for Promoting Christian Unity.

Pope John also wanted an *aggiornamento*, a renewal or 'bringing up to date' of the Catholic Church. Speaker Daniel G. Groody, CSC, PhD University of Notre Dame

#### A Pilgrim People, a Human journey: Theological **Perspectives on Migration and Eucharist**

There are 200 million people worldwide, roughly the equivalent of the population of Brazil, who are displaced from their homelands by wars, genocide, famine, natural catastrophes, and collapsed or withering economies. "When we look at the experience of migrants today, we see that they are hungry in their homeland, thirsty when they cross the desert, naked after having been robbed even of their clothing, imprisoned in detention centers, sick in hospitals, and then, if they make it across, treated as strangers. Professor Groody considers the complexity and urgency of the global phenomenon of migration, inviting us to respond with hospitality.



Daniel G. Groody is a member of the Holy Cross community, Associate Professor of Theology and Director of the Center for Latino Spirituality and Culture, University of Notre Dame. Drawing on years of work along the U.S.-Mexico border, he has authored various books including *Border* of Death, Valley of Life: An Immigrant Journey

of Heart and Spirit (2002), and co-edited A Promised Land, A Perilous Journey: Theological Perspectives on Migration (2007). Dr. Groody has worked with the U.S. Congress, the U.S. Conference of Catholic Bishops, the World Council of Churches, and the Vatican on issues of theology, globalization, and immigration.

#### **Human Rights and Church-State Relations:** The New Challenges

Tensions exist between the prohibition against discrimination on the basis of religion and the duty of the state to uphold neutrality and impartiality in terms of the freedom of religion. International organizations are reluctant to impose limits on states in this respect, thus downplaying the effective role of human rights. Professor Henrard will evaluate the Lautsi judgments made by the European Court of Human Rights, and investigate the argument that changed religious demographics further reduce the legitimacy of giving a special status to a religion that used to be adhered to by the vast majority of people in a country.



Kristin Henrard is a professor of minority protection at the Erasmus University of Rotterdam (EUR) and associate professor of Constitutional Law. She studied law at the Catholic University of Leuven, Belgium, with special focus on human rights and international law and obtained an LLM from Harvard Law

School in 1995. Her publications are in the areas of human rights and minority protection, including educational rights, linguistic rights, the principle of equal treatment and the prohibition of (racial) discrimination, the freedom of religion and the accommodation of religious diversity, socio-economic and political participation.

## A Faith that Loves the Earth

In this age of ecological stress, theology is rediscovering the natural world as a subject of religious value. In this lecture, Dr. Johnson traces how a Christian faith traditionally centered on human beings is growing to include the natural world in the definition of the 'neighbour' we are to love as ourselves.



After receiving a PhD in theology from the Catholic University of America (1981), **Dr. Elizabeth** Johnson taught at CUA before moving to Fordham. A former president of the Catholic Theological Society of America and of the American Theological Society, she was awarded Fordham University's Teaching Award in 1998

and Professor of the Year Award in 2011. Dr. Johnson is currently researching Darwin's idea of evolution in relation to the doctrine of creation so as to make care of the earth, an inescapable part of Christian life.

Head of the Historical Section of the Department of Foreign Affairs and International Trade, Ottawa

A Catholic Journey: Paul Martin Sr., Religion, and Politics Catholicism defined the private life and public career of Paul Martin Sr. (1903-92), one of Canada's leading politicians in the decades after World War Two. As a young man, he rejected the classical conservatism of a junior seminary in Québec, embracing instead the more tolerant version of Catholicism he encountered during the 1920s at St. Michael's College in the Protestant University of Toronto. Professor Donaghy will explore Martin's early faith experiences, and examine the resulting philosophy of social justice and political change that drove this young Catholic to challenge the status quo in Depression Canada.



**Greg Donaghy** received his PhD from the University of Waterloo in 1998 and became Head of the Historical Section of the Department of Foreign Affairs and International Trade in 2003. He has edited six volumes in the series *Documents on* Canadian External Relations, as well as several

collections of essays on post-war Canada, including (with Patricia Roy) Contradictory Impulses: Canada and Japan in the 20th Century (2008). His recent publications include the collection, Canada and the Hungarian Revolution: A Documentary Perspective (2004), for which Dr. Donaghy was awarded a Medal of Freedom in 2006 by the Hungarian Government.

## Vatican II: The Battle for Meaning

Professor Faggioli will address the history of the debate regarding Vatican II, and will focus on the core issues in the interpretation of the council today including whether Vatican II was a beginning or a renewal, the intertextual dynamic of the council texts, and the change and historicity in theology and in the Church. He will offer some hints about the 'clash of narratives' regarding Vatican II and restore the council in its historical and theological dimensions.



**Dr. Faggioli** worked in the "John XXIII Foundation for Religious Studies" in Bologna between 1996 and 2008, and received his PhD from the University of Turin in 2002. He is an Assistant Professor of History of Modern Christianity at the University of St. Thomas, St. Paul, Minnesota, and a member of the

research network, "The Lived History of Vatican II" at the University of Notre Dame. Dr. Faggioli 's book, Vatican II: The Battle for Meaning, was published in 2012 by Paulist Press. Liturgical Press will be publishing his upcoming book, The Implications of the Liturgical Reform of Vatican II.

Michael W. #### Nostra Aetate — the fruits of Vatican II for Christian-Jewish relations

The Vatican II document Nostra Aetate heralded a dramatic modern revolution in Jewish-Catholic relations, in particular, and Christian-Jewish relations in general. Nevertheless, many Christians and even Jews are unaware of how much of a transformation this has been. Rabbi Rosen will highlight the latter by summarizing the past Christian approach to Jews and Judaism, analyzing the significance of Nostra Aetate and how its teaching has been developed subsequently by the Magisterium, especially under Popes John Paul II and Benedi<mark>ct X</mark>VI. He will also indicate the challenges for the ongoing relationship.



**Rabbi Rosen** is the International Director of Interreligious Affairs for the American Jewish Committee and its Heilbrunn Institute for International Understanding. Among many positions, he is a founder of the Interreligious Coordinating Council in Israel that embraces some seventy organ<mark>iza</mark>tions in Israel involved in interfaith relations, a member of the Permanent Bilateral

Commission of the State of Israel and the Holy See and also of the International Jewish Committee for Inter-Religious Consultations. He is President of the World conference on Religion and Peace and Honorary President of the International Council of Christians and Jews.

Speaker Tariq Ramadan, PhD Professor of Contemporary Islamic Studies Oxford University, United Kingdom

# The Arab Awakening: Islam and the new Middle East Drawing from his recent book, *The Arab Awakening: Islam and the new Middle East*, Professor Ramadan asks: can Muslim countries bring together Islam, pluralism and democracy without betraying their identity? Will the Arab world be able to reclaim its memory to reinvent education, women's rights, social justice, economic growth and the fight against corruption? Can this emancipation be envisioned with Islam, experienced not as a straitjacket, but as an ethical and cultural wealth? He argues that the Arab world has an historic opportunity to stop blaming the West, to jettison its victim status and to create a truly new dynamic.



Professor Ramadan holds an MA in Philosophy and French literature and a PhD in Arabic and Islamic Studies from the University of Geneva. In Cairo, Egypt, he received one-on-one intensive training in classic Is<mark>lami</mark>c scholarship from Al-Azhar University scholars. He has contributed substantially to the debate on contemporary

Islamic issues, Islamic revival in the world, and Muslims in the west. Professor Ramadan is active both at the academic and grassroots levels, lecturing internationally on theology, Islamic law and jurisprudence, applied ethics, philosophy, social justice, economy, politics, interfaith and intracommunity dialogue

He has served as the bishop of St. Paul, Alberta, the Archbishop of

Edmonton, Alberta, and is currently the Archbishop of Toronto. Archbishop Collins was elevated to the College of Cardinals in February 2012 and has received honorary degrees from the University of St. Michael's College and Niagara University.

# It's your choice: a panel discussion on the significance

of posting emergency department wait times Given how often Canadians use the emergency department, reducing waits and improving th<mark>e</mark> patient experience is a priority for policy-makers. St. Mary's General Hospital started publishing live emergency department wait times online in April 2012 in an effort to provide patients with expectations on how long they will have to wait to be seen for non-urgent issues. While some say that this information is not helpful for improving the quality of emergency department services, those calling for more information say that people have a right to know how long they might wait when they arrive at an emergency department.
