# 4. Reports/Rapports

### Programme Chair/ Présidence pour le programme (Michelle Folk/Qamer Hameed)

Program Co-Chairs Report Canadian Society for the Study of Religion Monday, May 16, 2023 Submitted by Michelle Folk and Qamer Hameed

Congress 2023 is hosted by York University. Congress dates are May 27- June 2, 2023 making the start of our annual meeting Saturday, May 27, 2023. The CSSR President's Reception is scheduled for May 27 while the Executive meeting and AGM will be held later in the summer. This year the conference will be held in person for the first time since 2019.

The theme of Congress 2023 is *Reckonings and Re-imaginings* and is summarized (see attached program chairs' report from October 2022 for more information).

The early bird registration deadline for Congress 2023 was March 21, regular registration was April 1, and on-site registration is open as of May 26. There is a new underemployed attendee registration category defined as someone who is "employed part-time, seasonal or temporary and attending or presenting at an association conference."

This year, Chris Miller is supporting the program co-chairs in LAC responsibilities and has helped confirm the location of the conference rooms is sufficient for meeting needs. Additionally, Paul Gareau has kindly been providing meeting notes from the Congress 2023 conference planning meetings where he is able to attend.

The CFP closed January 31, 2021 this year. The draft program includes the following:

39 individual papers were submitted and grouped into 6 panels (adjustments will be made for any withdrawals).

We have had three withdrawals of individual papers and have needed to adjust the program slightly because of this.

1 workshop on Publishing Your Book on the Study of Religion. 3 roundtables including:

- From Their Mouths to Our Ears: Listening to a Generation on Living out an Ecological Spirituality,
  - Author Meets Critics: Religion, Spirituality and Secularity among Millennials,
  - The Handbook of Religion and Migration: Author Reflections.

2023 Plenaries part 1 and 2: Possible Roles, if Any, of a Scholar of Religion Regarding Promotion of Public Knowledge and Understanding of Religion.

The graduate student luncheon will be held on Monday May 29, 2023.

CSSR President's Reception is on Saturday May 27, 2023 from 5pm-7pm at McLaughlin College 014.

Congress 2023 President's Reception Hosted by York University is on Sunday May 28 from 5pm-7pm at Scott Library.

We are not scheduled to host the Craigie/International Speaker in 2023.

To date, the association signing authority, fees for Congress, membership list, conference details, rooms requests, association greeting table form, A/V and catering forms, open program information, and the final uploaded program have been submitted to the Federation through the Congress portal. Catering and room bookings were confirmed as well. We will likely update the program one more time and post to our website.

The program requires moderators, please let us know which sessions you are available to moderate and encourage other members to step forward as well.

We look forward to having a successful conference this year and would like to thank everybody for your help and ongoing support.

**Discussion:** Michelle notes that we have had 3 withdrawals so far. Rachel asks for a list of all these withdrawals so that she does not follow up with them about registration/membership

Michelle also shares that our bill for catering is currently projected at around \$3000. For reference, this is less than when Congress was at UBC, and more than when it was at Regina

Jacqueline asks about dietary concerns. Chris notes that Congress has not shared this information with us when we ordered, but we can follow up and inquire further. Rachel suggests that we submit a statement to Congress regarding the importance of inclusive food programs (for both dietary and religious reasons) for the purposes of accessibility and equity.

## <u>Communications Officer/ Agente des communications (Samiksa Love)</u> WEBSITE AND SERVER

- Website running smoothly at this time. I continue to be vigilant about bots/hackers trying to create accounts on our website.
- Hostpapa: is where our domain name is hosted since it offers .ca domains. Bluehost site nameservers are pointing to the Hostpapa domain name. We still have some credit on our account through Hostpapa so we will use the remaining amount to continue renewing our domain there every year. The most recent renewal was December 2022, and next one will be in December 2023. The total amount for renewal was \$23.72 (paid in December 2023), and we still have \$76.94 left in our account.
- Bluehost: Bluehost continues to be our web hosting provider, and the website is regularly maintained and backed up. Through Bluehost, basic web hosting was renewed until February 2025, and the SiteLock Security Essential feature renewed until February 2023. SiteLock Security Essential was paid for in February 2023 (\$131.52 CAD) and I was reimbursed by our CSSR Treasurer shortly afterward.
- A reminder that if the website ever goes down, it is very likely due to the index.php file needing to be re-uploaded properly, so please let me know if you ever notice the website is down (in case I don't notice it).

The website database is usually consistent with the list we send to CCSR (formerly we sent this to SAGE).

- Our Mailchimp newsletter service is still running smoothly. As of May 13, 2023, we have 557 subscribers to our Mailchimp mailing list (it fluctuates as people subscribe and unsubscribe. In October 2022 it was 555).
- "SUBSCRIBE TO OUR NEWSLETTER" option is still on our website's home page as well as under the "Connect" menu.
- Thank you to other CSSR Executive members who also send news to post onto the website and include in our newsletter each week.

# Membership Secretary/ Secrétaire des membres (Rachel Brown)

## **Membership Numbers for 2023:**

We have 94 folks, with some more to process, signed up and paid for 2023. The breakdown of membership categories is as follows:

Regular Members – 45

Associate receiving SR through CSSR – 11

Associate receiving SR through other society -8

Student receiving SR through other society – 18

Student receiving SR through CSSR – 12

I am waiting on a few more folks to register ahead of presenting at Congress. I emailed those who had not yet registered for 2023 membership and who are slotted to present. There were about 16 people who still needed to do so. If all of them register, that will put us at 110 members.

**Discussion:** Diana suggests that we need to be strict about unregistered presenters and follow up with an email to ensure that they register before the conference. Zabeen suggests that in an effort towards inclusion, we should offer a grace period to register. Executive agrees that we will follow up with an email as a reminder.

## <u>Treasurer/ Trésorier (Paul Gareau [Interim])</u>

#### **Interim Status:**

I had to step in and take over as treasurer from Ted this winter. We are hoping to secure a new treasurer at the AGM in June 2023.

## **Clear Up BMO Account:**

Once we have elected a new treasurer for the CSSR, we need to clear up the BMO account for who has signing power. I will bring in the minutes from our next AGM to make sure our account is up-to-date.

### **Travel Funds:**

There are only 4 legitimate claims for the travel fund, totaling \$1,599.76 out of \$6,500.

#### **Account Status:**

Current

• Community Account: \$20,092.18

• BMO Mutual Funds Investment January 1st, 2023: \$67,389.66

• Total Income: \$87,481.84

#### E-transfer:

E-transfer is working out well. We had international members who couldn't access the BMO e-transfer. We sent them a way to wire the money. Unsure if they were able to complete their membership at the time of this meeting.

## **Outgoing Expenses:**

- SR subscriptions were paid out to the CCSR for 2022 and 2023: \$920 + \$1,540 = \$2,460.
- IAHR dues will be sent out this week. Fees are 2.40 Euro per member, after the exchange and wire transfer fee it worked out to 489.09.
- Zoom account: Is now paid directly from the BMO account.
  - Annual Fee (March 8th): 200.00 + 10.00 tax = 210.00
  - Monthly Cloud Storage (8th of every month): \$53.00 + \$2.65 tax = \$55.65

**Discussion:** Paul adds that the Zoom account has been transferred to Zabeen

Paul also notes that only 4 travel funding applications were received. Rubina suggests that if we have so few travel funding applications, we should start promoting it to Faculty, sessionals, and others

# Graduate Student Member-at-Large/ Étudiants des études supérieures (Michael Gillingham)

#### Student Ambassador Program

Now in its seventh year, the Student Ambassador program is continuing to run. We have added two Student Ambassadors to the list since my last report for a total of 13 Student Ambassadors for this year. Our two newest ambassadors are Faezeh Izadi (University of Calgary) and Ankita Choudhary (University of Toronto). We have continued to advertise for new Student Ambassadors on our website and through the newsletter. I sent out two updates to the ambassadors in January 2023 reminding them about opportunities for funding and also reminding them about the call for papers for the CSSR meeting at York University during Congress. ## **Student Reps Joint Project**

I've been involved in a conversation about planning some joint events with student representatives from other organizations similar to CSSR in Canada. We are currently working on plans for a webinar for MA and early PhD students on writing and presenting conference papers, and the difference between a conference paper and journal article. # Members-at-Large (Jacqueline Giesbrecht and Kalpesh Bhatt)

Advertising for this year's essay contest has begun, and we've received our first submission! More details about the contest can be found on the <u>website</u>, along with this year's poster.

We've continued to be in conversation with Samiksa, confirming and updating contest details on the website. The submission deadline will once again be on August 1<sup>st</sup>. The undergrad word limit was increased to 2500-5000 words, with the hope of drawing students taking upper-year courses or doing independent studies. As discussed at the previous meeting, the student winners will be invited to share their papers during the 2023-2024 CSSR Webinar series. The contact for essay submission was updated (from Paul to Jacqueline and Kalpesh), and we've created a shared Google folder for collecting the essays.

**Discussion:** To reflect the changing nature of scholarship, and the work that students are being trained to produce, discussion of whether we should open the student essay contest to better reflect this diversity of thought and writing. Expand the criteria to allow for policy papers, podcasts, other forms of media and writing. Chris suggest that by changing the name from Student Essay Prize to Student Paper Award, this could broaden the scope on its own, as the description of what is eligible is already quite open.

If we would like to make this change, it must be raised at the upcoming AGM, and could then be implemented after this current open contest finishes (August 1, 2023).

**MOTION:** The CSSR will create a third student prize that evaluates non-traditional scholarly work, open to all undergraduate and graduate students. Prize amount is \$300.
