Programme Chair/ Présidence pour le programme (Michelle Folk/Alison Marshall)

CSSR Program Co-Chairs Report Fall Executive Meeting Submitted by Alison Marshall and Michelle Folk October 3, 2023

Congress 2024 is being hosted by McGill University. Congress dates are June 12-21, 2024. **Our annual meeting is scheduled June 15-18, 2024.** The theme of Congress 2024 is *Sustaining Shared Futures* and is summarized as,

While alarming images of a warming planet infuse the concept with a critical sense of urgency, 'sustainability' transcends even the immense challenges posed by climate change, urging recognition of the interconnectedness of human existence and global action on the

overlapping social, economic, environmental, and technological issues that threaten our future.

As members of the global community, we share the responsibility to take on this multifaceted challenge of a lifetime by way of concerted action across disciplines, bringing into focus its unequal impact, the bounds of our planet, and in turn, our solutions.

For this 2024 edition, enmeshing the knowledges of diverse contexts, and amplifying Black and Indigenous perspectives, Congress invites scholars, students, policymakers and community members to reflect on what remains collectively attainable – and what must be done – in the face of this vast and complex imperative in order to bring forth solutions for today, and sustain systems of tomorrow (<u>https://www.federationhss.ca/en/congress2024</u>). Diana Dimitrova has kindly agreed to be the **local area coordinator** this year. The Federation's annual planning meeting took place on September 20 at McGill.

Historical data in the Federation's organizers portal shows attendance was down last year but *we anticipate that it will rise this year*:

Registration opens January 25, 2024. Registration categories: regular attendee, reduced fee for attendees who self-identify as underemployed or as post-doctoral researchers (new category that appears to now include post-docs), special reduced fee for attendees who are students, K-12 educators, retired, and unemployed, *Black or Indigenous students who self-identify to their associations, community, and Black or Indigenous attendees. Registration deadlines: early-bird (March 31), regular (April 1), on-site (June 11). *<u>Until the online submission system is revised, we propose that submissions include in the abstract whether the person submitting or presenting identifies as black or indigenous.</u>

Congress asks that associations follow its daily programming schedule to accommodate for other programming and suggests the following daily schedule:

8:30–10:00 Session 1 10:00–10:30 Break 1 10:30–12:00 Session 2 12:00–13:30 Lunch 13:30–15:00 Session 3 15:00–15:30 Break 2 15:30–17:00 Session 4 18:00 + Special events, AGMs, joint sessions, receptions, open events etc.

Room bookings: We were told at the planning meeting that there are overall fewer rooms at McGill than last year at York. Rooms will be available at upper and lower campuses and will accommodate Zoom. Rooms holding over 20 people will have a screen and projector. Unlike last year, there is no deluxe A/V package but only the basic package. Associations that plan on hybrid sessions need to provide their own technology (e.g., laptops). *There is an option to add additional chairs and tables to rooms. Some rooms may need panel table and chairs at the front of the room which must be ordered in advance and at an additional cost. Rates for additional furnishings will be provided later.*

Funding opportunities include the open program fund, which we used last year for the plenary session (February 2, 2024 deadline). We received \$250.00 for Congress 2023, which was used towards catering.

Congress Graduate Merit Award: The Federation is providing funding for graduate students through the Congress Graduate Merit Award (CGMA). Students must be an MA or PhD student in good standing at a Canadian university, a member of the association, and submit a 250-word (max.) abstract of their presentation to the CSSR. The CSSR executive must then nominate a set number of candidates to the Federation. The Federation decides the number of nominees based on association size. Last year we have 1 CGMA. We can submit our list of nominees until April 19, 2024. The Federation will notify the CSSR executive of accepted nominees between October 16, 2023-April 19, 2024. Payments will be sent to students' bank accounts in July, 2024. <u>Until the online submission system is revised, we propose that submissions include in the abstract whether the person submitting or presenting is MA or PHD student(s) (with link to their university program and information so that we may contact reference at the institution). This will enable us to expedite our determination of qualified candidates for consideration for this award.</u>

Childcare subsidy: We had 1 child/dependent care subsidy last year. The number is based on membership size and determined by the Federation. Eligibility: presenter, moderator, chair, or respondent at Congress, member in good standing with the association, registered for Congress, and submission of a 250-word (max.) application detailing professional status, needs, and costs to the association. We are required to endorse someone by April 19. The Federation will notify the recipient by May 3. <u>Until the online submission system</u> is revised, we propose that submissions include in the abstract whether the person submitting or presenting would like to be considered for the childcare subsidy. This will enable us to expedite the process.

Deadlines: Upcoming deadlines in the organizers portal: signing authority form (October 15), membership list (November3), conference fees form (November 10), conference details form (November 10) and room requests (November 24).

Meetings: Program co-ordinators met October 3 to discuss programming for the 2024 McGill meetings and will be attending regular Congress operated meetings in addition to CSSR executive meetings and will follow up as required.

Discussion:

- Chris Miller suggests a Google Form for abstract submissions, as opposed to Sunflower
- Rachel confirms that Sunflower will not be part of our new website, so we need an alternative
- Christopher Austin asks whether the Revenues shared in report go to us, or to the federation
 - Diana answers that this is correct. That figure basically goes as a credit towards the invoice we receive from Congress
- Rachel also suggests advertising the new dates for Congress in our next Newsletter

Update: Diana explains that Samiksa had to step down from the position of Communication Liason for health reasons. Christopher also had to take on a share of the Membership Secretary tasks, since they relate to our finances. Treasurer/ Trésorier (Christopher Austin)

Christopher Austin Treasurer, CSSR Oct. 4th 2023 Meeting

Updates and Issues

- Attached are 2022 and 2023 (to-date) expense and revenue reports. Will be asking for clarification on yellow items from exec. in meeting.
- BMO account transfer of signing authority from Paul to myself is now complete: I can access account online, make and receive E-payments. Still waiting for Paul to snail mail me the physical cheques, but we won't need these often.
- A new CSSR Treasurer email account is now up and running; this is linked to BMO account and Paypal.
- Ruby has set up the Paypal and she and I worked out the details for me to access it. I should now be able to receive new and renewed memberships, and use the Paypal to manage membership data. Thanks to everyone for setting that up!
- At its AGM this year, the CSSR adopted a roughly \$14,000 deficit budget and since Jan. 2023 is running a \$9,660.84 deficit. That amount excludes any money owed for 2023 Congress (is that usually paid out mostly in Dec. of the prior year?). To avoid any future deficit budgets, I will urge the CSSR to consider dropping the executive honoraria and Zoom account.

Questions

- Who has access to the investments portfolio? Do we have a CRA profile for the CSSR to pay taxes on investment interest? We owe 2022 taxes on the interest from these investments and almost certainly from prior years.
 - This question was not answered during the meeting
- Samiksa was paid \$2000 in June 2023 -- was this for website work over July 2022 June 2023 or an advance on the upcoming July 2023 June 2024 year?
 - Diana answered that this was for last year's work
- We have many \$400 item expenses -- are these student awards? Again, any tips people can give me on the yellow items in the attached files will be most welcome.
 - Brief discussion of the likely source of these item expenses. Most of them are likely student awards as well as honouraria

Discussion:

• Christopher offers a strong warning about the dangers of adopting a deficit budget. We will very soon run the risk of going into the red if we continually overspend our revenues

- Recommends dropping the Executive Honouraria, which would remove over \$5000 of expenses
- Diana notes that there will be a savings in the projected budget, since the web developer that Rachel has been working with will cost less than was estimated for Samiksa
- Zabeen asks whether Christopher has been creating better records, especially considering the confusing situation that he (and Paul before him) had to take over
 - Christopher has been creating better records, with the idea of making future transition easier
- Diana notes that she is not in favour of scrapping the Honouraria for Executive members
 - Suggests that we may think about scrapping our reception at the conference

Discussion:

Members-at-Large (Jacqueline Giesbrecht and Kalpesh Bhatt)

2023 Essay Contest

The Call for Student Essay Submissions commenced in April 2023, with August 1st as the deadline. This year we received a total of 11 student essay submissions, 5 of which were undergraduate submissions and 6 of which were graduate submissions (2 Master's and 4 PhD). While we only received 1 French essay submission in 2022, this year we received 4.

Kalpesh and I adjudicated the essays in September 2023 and are in the process of finalizing the winners. The PhD category is quite close between a French and an English essay, so we have decided to ask for a third opinion.

Undergraduate Prize

We had increased the upper word limit to 5,000 words to match the graduate competition's. This change was beneficial, as most undergraduate submissions were within 10% of this new limit.

1st Place (\$250) – Audrey Miatello, University of Toronto

"Reconnecting to Nature in the 21st Century: Considering Laudato Si' as a Guide"

This paper presents a commendable effort to explore the role of religion in the conservation of nature and ecology. The author argues that the contemporary disregard for nature and the pressing issue of climate change can be traced back to our increasing detachment from the natural world. We, as humans, have undervalued the importance of nature and do not appreciate its significance in our lives. Considering this is an undergraduate paper, it is impressively well-written and thoroughly researched. The author proposes that embracing the concept of interconnectedness as a religious ethic could offer a significant solution to this pressing issue. While there is room for a more indepth and sustained exploration of this topic, the paper stands as an excellent endeavor to leverage religious ethics and values to address a contemporary global concern.

2nd Place (\$100) – Claire Hamilton, Queen's University

"Gnostic Conceptions of Genesis"

This paper provides a well-articulated exploration of the Gnostic interpretations of the Genesis accounts found in the Hebrew Bible. It effectively elucidates how Gnosticism portrays the Hebrew God as a Demiurge, an intermediate deity with inherent imperfections. The Gnostics achieve this by reinterpreting passages within the Bible to assert that the true transcendent God exists beyond this Demiurge. Throughout the paper, the author adeptly alters the characters of the Hebrew God/Yaldabaoth, the serpent, Eve, and Seth to construct an alternative Genesis narrative that sharply contrasts with orthodox Christian accounts of Biblical Genesis. While this paper primarily serves as a comprehensive summary of Gnostic arguments and doesn't introduce a new or entirely original perspective, it is nonetheless a well-articulated and thoroughly supported piece of work.

Graduate Prize

<u>Master's Prize</u> (\$300) – Marie-Ève Ouimette, Université du Québec à Montréal (UQUAM)

<u>PhD Prize</u> (\$650) – TBA

We had some questions about essay length, since some graduate students hoped to submit an essay they had written for a journal (~7,000 words).

Question: Would we be interested in increasing this word limit?

Observations and Suggestions

We received emails with various repeated questions before the competition deadline. Some of these can be easily clarified, while some may take further discussion among exec.

The deadline (midnight August 1st) – There was some confusion due to the ambiguity of how midnight works on a calendar. Changing it to 11 p.m. instead (and specifying a timezone) would help clarify this for the future.

Eligibility

We received a lot of questions about eligibility. The most frequently asked questions were about current registration status, the letter of confirmation/certification, CSSR membership, and the differences between undergraduate and graduate eligibility.

Reflecting on and clarifying the requirements may help increase future submissions. Comparing the undergraduate and graduate eligibility will be useful for creating the new prize category, as this prize will be a single combined competition.

Current Registration

Questions about registration mostly came from undergrads not studying during the summer term and those between their undergrad and Master's. We decided to go with "current" meaning those registered for the 2022/2023 school year (Sept 2022 - August 2023, even if not during the summer term) or those already accepted into a graduate program (as of August 1st).

Suggestion: "was registered in the preceding academic year (September - August) or is currently registered in a _____ for the upcoming academic year"?

<u>Canadian University vs. Canadian Citizen</u>

We received no questions about this, but this would be important to clarify for the new competition.

Question: Do we want to allow Canadian undergrads studying abroad to submit essays, like in the graduate competition?

Letter of Certification

Some students had trouble getting a letter of certification. The student from Athabasca wasn't sure who to email, as the course was online and no religious studies department existed. Another student emailed their department chair and was told to use the autogenerated confirmation of enrollment.

Question: What is the purpose of the certification letter? Do these descriptions continue to meet our needs and current university bureaucracy?

• Current enrollment? Academic Integrity?

- Does it need to come from the RELS department/chairperson?
- Could they get it from someone else (undergrad \rightarrow home department?)
- Is an auto-generated confirmation of enrollment fine?

• Status

- Do we care about full-time vs. part-time status?
 - E.g., can a student taking one course at Athabasca submit an essay they wrote for that course?

CSSR membership

A CSSR membership is required for the graduate competition but not for the undergraduate competition. Would we like to continue with this? If so, adding a clarifying sentence in the undergrad description would be helpful, as I (Jacqueline) misread this myself and misinformed a student.

Publicly Engaged Research in Religion

The discussion about essay prize eligibility will also help to move the new student prize along. The changes made today will be added to the <u>Google doc</u> with the new prize description. This draft will presented at the Spring meeting for further discussion and final approval. Until then, please feel free to provide your feedback about the new prize in the Google doc or over email.

Discussion:

- Based on the questions for eligibility above, brief discussion over how to finetune these details
- In terms of registration requirements, we agree that registration status from the previous year (September to August) should be what counts. In other words, an undergraduate student who plans to enter a MA program would still submit to the 2024 undergraduate essay contest
- Concerning question of location and citizenship, Christopher says that our bank account only allows students registered at a Canadian university to submit, since they are the only ones we can award the prize to. This means that undergraduates studying abroad can submit, so long as they have a Canadian bank account
- Concerning the question of degree program, we agree to open it up to disciplines outside of Religious Studies. While the topic of the essay still needs to be in the study of religion, students can be enrolled in other programs (e.g., Cultural Studies, History). Brief debate over whether this expands it too far, as Christopher and Kalpesh express concerns about people submitting essays from other fields. Zabeen and Chris suggest that the eligibility requirements should be broad, and essays that are deemed to be too far outside the study of religion just won't be selected as winners
- Due to time constraints, we could not discuss all of the questions raised in MAL report. Issue of whether the certification letter should still be a requirement still needs to be addressed/resolved
